The role of Principal is currently clear and well understood. The EIS does not view HEIs as commercial organisations and therefore believes that the use of the term Chief Executive Officer to be inappropriate. The use of the term Chief Executive Officer would further distance Principals from the academic staff. Also, the use of the term would not reflect the custom that Principals usually come from the academic staff – a custom that the EIS wishes to reinforce.

However, whilst the EIS does not support the Government's use of the term, it does believe that ultimately it should be up to individual HEIs to decide what their Principal is called.

The EIS supports the remuneration of elected Chairs within reason. The EIS does not believe that the remuneration should be set at a level to specifically attract candidates – but it should be used (and set at a level) to ensure that Chairs do not lose out financially by accepting office.

The role of the Chair and how a Governing Body (and its Committees) meetings are conducted need to be more consistent across the HE sector.

The EIS commends the Code of Governance developed for FE Colleges in Scotland by the FE Sector collectively – which included the College Chairs, College Secretaries, SFC, Trade Unions and the NUS. The EIS believes that the HE sector would benefit to such a collective approach.

E. MEMBERSHIP OF GOVERNING BODIES

The preponderance of retirement age members is a further cause for concern for the EIS.

HEIs should consider paying facility time to release working members of Governing Bodies as well as paying child care costs.

24. Do you have any other comments you wish to add?

The EIS supports the addition of directly appointed trade union representatives on the governing body. Such individuals should bring knowledge and experience to the body that will allow greater informed debate on some matters and thus improve scrutiny.

Trade Union representatives also have a direct democratic link with members which makes them accountable and which also give them a mandate. The EIS believes that Trade Union organisation, training and democratic open elections would make Trade Unions the most appropriate vehicles for delivering the best possible additional staff representatives – providing elected representatives with training and confidence to fully contribute to Governing Bodies.

The EIS has submitted its views on Governance to the Scottish Government in past consultations, the Von Prondzynski Review and to the Scottish Committee of University Chairs. These submissions are available at the EIS website.

The academic integrity of a HEI is crucial; HEIs are teaching and research institutions that have traditionally been run by promoted academics for the furtherance of teaching and learning. A HEI's reputation is rightly judged by the quality of its teaching and research – and not by its operating surplus or closing reserve.

The EIS believes that academic matters should not be entrusted to University Executive Management Teams – but should be the main responsibility of Academic Boards (i.e. Senates or their equivalent). Governing Bodies should charge their Executive Management Teams to deliver the decisions of Academic Boards. Academic Boards need to be bodies that reflect the will of the academic staff, not the will of University Executive Management Teams.

The EIS is not blind to HEIs' need for financial security, stability and investment, and recognises the need for Governing Bodies and senior

managers to be mindful of these. However, the value of maintaining and building on teaching and research should not be considered in primarily financial terms by HEIs and thus should not be primarily driven by financial considerations. The universal education provided by HEIs must be able to deliver a wide range of popular and less popular courses – and Academic Boards are the best guarantors of this.
