Following submission of the Teachers' Side pay claim of 10% a meeting of the Extended Joint Chairs was held on the 23rd March and a differentiated pay deal of 2 and 3 per cent was offered. The teachers' side of the SNCT has rejected this offer.

Scottish National Standardised Assessments

As we enter the final term of the school session when many schools will be implementing SNSA's, the EIS continues to monitor approaches to implementation and remains firm in its position that all assessment should support learning, should be timed appropriately as determined by teacher professional judgement, and should not be conducted with whole cohorts at once. Action for Representatives:

School Reps are advised to monitor the use of SNSAs at school level with a view to ensuring compliance with EIS policy and Scottish Government advice https://standardisedassessment.gov.scot/teachers/. Emerging issues, for example, with regards to training; the timing of, presentation patterns for, or misuse of data from, SNSAs; or of continuation of other forms of standardised assessment should be raised with the Headteacher in the first instance and the Local Association Secretary informed should the matter remain unresolved.
