I am writing to urge you to vote for the EIS endorsed candidates in the forthcoming GTCS elections. Now more than ever, it is crucial that you do so.

In light of the Scottish Government's proposal to disband it, the GTCS is fighting for its survival.

Despite the GTCS being an internationally regarded, teacher-led professional body that is almost fully funded by teachers' subscriptions, the Government has outlined plans to transfer the functions of the GTCS to a new Education Workforce Council whose membership will comprise all of the education workforce.

We don't always agree with the GTCS but we recognise it as an independent voice capable of saying 'No' to Scottish Government, when required.

Critically, the Scottish Government plans to get rid of the democratic process by which teachers are elected to Council, holding a slim majority. Instead, the Government intends that there will be no elections, that Council members will be appointed by Scottish Government, and that professionals will no longer hold a majority on what will be a Board, not a Council.

The EIS believes that this proposal from the Scottish Government poses a real threat to the professional status of teachers, to the custodianship of high standards, and to the support that the profession receives from the GTCS. As a bastion against moves to facilitate fast and faster-tracking into the profession, the GTCS must remain intact.

The threat to its existence must be resisted and the role of the GTCS defended by teachers. At this time of great change in Scottish Education and increasing pressure in our schools, it is important that the teacher voice is strongly maintained and clearly heard within our own professional body, the GTCS.

The EIS is supporting a number of candidates who are committed to meeting this objective and who are:

- classroom teachers and headteachers who are EIS members
- individuals who command the respect of colleagues in their schools
- · committed to promoting the highest standards within the profession
- committed to defending teachers in the face of the many challenges faced on a daily basis in our schools.

I believe strongly that their experience, taken together with their personal integrity and commitment, equip them well to represent colleagues on the GTCS Council, not least in terms of fighting for its future.

When the elections open online in January, please vote for all EIS supported candidates.

GTCS matters for every teacher

The EIS supports the work of the General Teaching Council for Scotland (GTCS) in its significantly important role in Scottish education. The work of the GTCS impacts on teacher professionalism and the work of teachers throughout their careers. This role is of particular importance in light of Professional Update, the development of teacher professionalism and the need to enhance the status of the teaching profession.

Why strong teacher voice on GTCS Council matters

- To be able to teach in Scotland, every teacher must be registered, and remain registered, with GTCS.
- The GTCS sets 3 professional standards; The Standard for Registration, The Standard for Career-Long Professional Learning and The Standard for Leadership and Management.
- The GTCS accredits Initial Teacher Education as well as playing a critical role in the area of professional learning.
- Cases of alleged teacher misconduct or incompetence are reported to GTCS, which has the right to use the ultimate sanction of removing teachers from the GTCS Register.
