Pay Claim 2018

The EIS and other unions will shortly begin negotiations with local authorities and the Scottish Government on the 2018/2019 pay settlement for Scotland's teachers via the Scottish Negotiating Committee for Teachers (SNCT). The next meeting of the full SNCT takes place on Thursday 8 February 2018 and will consider the pay claim from the Teachers' Panel of the SNCT.

The EIS Council meets on Friday 26 January and will determine the terms of our pay claim for 2018. This claim will then pass to the EIS representatives on the SNCT who, along with the other unions, will formulate the Teachers' Side pay claim at a special meeting of the SNCT Teachers' Panel on Monday 5 February 2018.

The EIS values the SNCT and remains committed to its future in the negotiating procedures. The EIS believes pay should be restored to pre-austerity levels, however, and will ask members to consider industrial action if negotiations fail to deliver this.

Council Elections 2018/19

The EIS Council is the principal executive committee of the EIS. It meets around five times a year, usually in Edinburgh, and at the AGM.

GTCS Elections

Voting has opened in this year's elections to GTCS Council. It is crucial that you use your online vote to support all ten of the EISendorsed candidates who are standing in this election at a time when the very survival of the GTCS is under threat.

The Scottish Government's current proposal for the creation of an Education Workforce Council to replace the GTCS, poses many risks to the power of teacher voice in shaping teacher professionalism and professional standards.

The Government's proposal would disband the Council to which teachers are democratically elected, replace it with a board and remove the teacher majority - in other words, ensure less teacher input and more political direction.

The EIS is seeking to defend the GTCS from such damaging political interference. To this end, we are supporting ten strong candidates in this election. Please encourage members to use their vote to give them their full backing.

Booklets containing the EIS endorsed candidates' election statements as well as guidance on how to vote on the GTCS website, have been issued to all schools - additional copies are included. **Voting closes on Friday 2nd February**.

New EIS Guidance on Distribution of Period Products

The EIS recently launched a new good practice guidance note on "Distributing period products in schools and colleges". This guidance aims to help educational establishments to support learners and staff during menstruation, which is a normal part of life. It contains some suggested 'Do's and Don'ts' for schools and colleges regarding the provision of sanitary products.

The guidance can be read alongside other EIS publications on gender equality such as, 'Get it Right for Girls' and links to ongoing campaigning to highlight the impact of poverty on education.

EIS Page Scholarship 2018/19

Application forms are now available for the 2018/19 Page Scholarship involving a research visit to America, offered by the EIS in association with the English-Speaking Union. Besides being EIS members, applicants must also have 5 years' teaching experience.

The Scholarship is awarded annually to a teacher/lecturer in a Scottish school/college and is intended to promote smallscale educational research and exchange of ideas between Britain and America. The successful Scholar travels to the USA to study a specific aspect of American education which interests her/him, and which is relevant to her/his own professional responsibilities here in Scotland.

The value of the EIS Page Scholarship is $\pm 2,400$ which covers the cost of travel to and accommodation in, the USA. Throughout the visit, the Scholar is the guest of the American Branches of the English-Speaking Union. The closing date for submission of applications to the EIS Education Department is **Thursday 1 March 2018**.
