Professional Learning Opportunities from the EIS

New training courses and workshops are available to book now:

Equality and Human Rights in the Classroom - a free, one-day course looking at the UN Convention on the Rights of the Child, the Equality Act 2010 and how to bring a rights-based approach to learning. Open to both teachers and college lecturers.

Building Teacher Leadership - Leadership Skills for Classroom Teachers – a free, two-part course delivered over two Saturday mornings, aimed at unpromoted teachers and lecturers, which will explore pedagogical and other types of leadership in the school / college setting.

The Gwen Mayor Memorial Trust was established in March 1996 following the tragic events in Dunblane Primary School on 13 March 1996, when teacher, Gwen Mayor, lost her life along with 16 pupils.

The purpose of the Trust is “to advance education by providing financial support for projects in connection with the arts, culture, music or sport submitted to the Trustees by primary schools or departments in Scotland.”

Applications are now invited from primary schools and departments in Scotland. Proposed projects should fall within the purpose of the fund as set out above. Requests for full or partial funding of projects will be considered.
