Recruitment

As you will be aware, it is always important at the start of term to identify new staff members and to ensure that their membership details are transferred or, in the case of new teachers and probationers, that they are recruited into the union. Statistics show that the single biggest reason individuals give for not joining a union is that they are simply never asked. Your role as a school Rep or Branch Secretary, therefore, is absolutely vital in this regard.

Violence in the Workplace

The EIS recognises that the issue of violence in schools is a major concern for EIS members. As a result of an AGM Resolution, posters with information and advice on working with violent and disruptive pupils have been produced.

Teachers are encouraged to report all abusive incidents including violence, threats of violence and verbal attack.

In addition, any EIS member who has been subject to violence in the workplace has an absolute entitlement to raise a complaint with the Police. Members are advised that, unless there is a police report and a complaint, the Criminal Injuries Compensation Authority (CICA) cannot award compensation to victims.

Membership Lists

It is important that our membership records are as accurate as possible; membership lists are available online and should be updated regularly with any changes to the staffing within your school.

Refreshed EIS Advice on Education Scotland Inspections

The EIS has updated advice to members on Education Scotland inspections, taking account of the recent changes that there have been to the procedures surrounding them. Gwen Mayor Trust

The Gwen Mayor Memorial Trust was established following the tragic events in Dunblane Primary School on 13 March 1996, when teacher, Gwen Mayor, lost her life along with 16 pupils. The purpose of the trust is "to advance education by providing financial support for projects in connection with the arts, culture, music or sport submitted to the Trustees by primary schools or departments in Scotland."

Applications are now invited from primary schools and departments in Scotland. Proposed projects should fall within the purpose of the fund as set out above. Requests for full or partial funding of projects will be considered.
