Covid-19 Update

A recent Covid update was issued to all EIS members and included information and guidance about the new Omicron variant. The bulletin is available to view on the Member Bulletins section of the EIS website (www.eis.org.uk/News/Bulletins).

Included with this Reps' bulletin is a "Letter to all early learning and childcare (ELC), schools and higher and further education settings: Omicron variant" concerning the current Covid-19 Omicron variant situation. This letter was recently issued from Public Health Scotland to Directors of Education to offer clarity in the current, rapidly developing situation.

Ventilation

EIS Curriculum and Pedagogy Guidance

The Education Department has updated the EIS Curriculum and Pedagogy Guidance for Primary, Secondary, Special Education (Primary) and Special Education (Secondary). This is accessible in the Covid section of the EIS website. The updates take account of adjustments to the Scottish Government Guidance on School Trips.

Probationer Teacher Recruitment

New Probationers: There may be current probationer teacher colleagues who have not joined the union. EIS membership is free for all current probationers until December 2022. After that, probationers can get a further 50% discount on full membership for the following nine months if they update their direct debit details with us by the end of their 18-month free period. If they joined the EIS as a student then they should update their membership details, for example school details, at the start of their probationary year. This will assist us in continuing to offer support.

Previous Probationers: There may still be teachers in your school who are no longer in their probationary period but did not join at the end of their free membership (ended Dec 2020) - please check and follow up, if they did not set up a direct debit with the EIS they are not members.

Action for Reps: Please approach any new probationers or colleagues who are recently out of their probationary period in your school and encourage them to join for free.

Council Nominations 2022/2023

The EIS Council is the principal executive committee of the EIS. It meets around five times a year, usually in Edinburgh and at the AGM.

Nomination forms for members interested in standing for election to Council for 2022/2023 will be available from the EIS website.

We encourage members of the EIS BAME, Disabled and LGBT Networks to consider standing for election to Council. Being part of EIS Council can be an empowering and beneficial experience, and an opportunity to raise the profile of issues you care about. Further details can be found in the enclosed flyer.

National Occupational Networks – Additional Support Needs, Educational Psychologists, Headteachers and Depute Headteachers, and Instrumental Music Teachers

National Occupational Networks operate to represent certain members who are part of an occupational group within the EIS, who have distinctive interests and who may not be represented in other structures within the Institute. These groups operate on behalf of four categories of members – Additional Support Needs, Educational Psychologists, Headteachers and Depute Headteachers, and Instrumental Music Teachers.

Networks operate to offer a forum for such members, to keep the main body of the EIS advised of developments in these areas and to allow proper assistance to be offered to these members in matters which affect them.

New elections to the Networks are now underway, and EIS Representatives are asked to ensure that their Headteacher/Depute Headteacher (where a member) and any other relevant members in their establishment are made aware of these elections and have the opportunity to nominate themselves for election.

One Network representative is elected for each Local Association area and members may nominate themselves. The period of office is three years and Networks normally meet on around two occasions each year.

Online nomination forms are now available to applicable members on "MyEIS" and should be completed prior to 17th December 2021.

Action for Reps: Please ensure that information on this election is brought to the attention of your Headteacher or other relevant categories of members in your establishment, and that suitable members are encouraged to stand.

No Planet B

A reminder that the EIS No Planet B digital exhibition of pupil work on climate education is open. EIS members are welcome to visit the exhibition with (or without) their pupils and to leave a message of encouragement for the contributors to see in the Visitors' Book.

The exhibition will be open for some time and members are welcome to add further contributions of climate themed pieces of pupil work at any time during the remainder of this academic session. All schools/classes who contribute will receive an eco-friendly certificate and all individual young people, a biodegradable badge to mark their contribution to the exhibition.

Welcome Packs for Young People Arriving in Scotland

In response to the arrival of Afghan refugee families to Scotland, the Equality Department has updated the Welcome Packs for young people arriving in Scotland to include translations in Dari and Pashto, in addition to French, Polish and Arabic. Hard copies will be sent out to local authorities early in the new year when we also plan to provide audio recordings in each language to accompany the Parents' Guides.

In the meantime, all of the information packs are accessible online and available to download, in all of the aforementioned languages via the EIS website.

Collaborative Action Research: Facilitator Training Sessions in January 2022

EIS Members are invited to take part in a new Collaborative Action Research scheme to support their professional learning.

Across 2021-22 the EIS is planning to support members in undertaking collaborative action research to further professional learning and empower teachers through practitioner enquiry.

This will involve developing programmes of collaborative practitioner research and enquiry, with members who are pursuing overlapping or complimentary topics networked into 'Action Research Clusters' supported by EIS members trained as 'cluster facilitators'.

These clusters will facilitate peer support, information sharing, professional learning and collaborative agency. This will enable teachers to play a more empowered role in promoting learning through collaborating with other professionals.
