Time to Tackle Workload!

Following the success of the Value Education, Value Teachers campaign in securing the pay deal, the focus will switch over the next session to tackling workload.

This is a major agenda for members, as testified to in the survey we carried out, and the pay agreement itself spoke about tackling excessive workload through the empowering schools agenda. A strong initial focus will be on ensuring that WTAs are utilised effectively to exercise some control over excessive workload.

Branches are entitled to seek time on the initial inset days for an EIS meeting and it is strongly recommended that you seek agreement now for this to happen. Initial campaign materials to facilitate discussion at such a meeting will be sent out over the summer, alongside visual materials, so that we are ready to begin building the 'Time to Tackle Workload' phase of the VEVT campaign in the new school session.

Action for Representatives: Please seek agreement for an EIS meeting within the inset days, if this is resisted you should seek support from your LA Secretary, but seek to arrange an EIS meeting in any case. Look out on your return for materials which should have arrived over the summer.

EIS-FELA Consultative Ballot Update

The result of the EIS-FELA pay ballot is 88% voting to accept and 12% voting to reject, on a turn-out of 66%. Whilst this is a significant majority, the improved offer was achieved only as a result of the sustained campaign of industrial action which you carried out. Thank you for your persistence and resilience throughout this campaign.

As a consequence of the ballot decision, the action short of a strike – both in terms of the resulting boycott and the withdrawal of goodwill – has now ended. Early implementation of the pay agreement will be sought from the employers. Thank you, again, for your support throughout this campaign.

Action for Branch Secretaries: Please make members aware of the advice issued in relation to 'catch-up' work and arrange meetings with college management to determine how any backlogs arising from industrial action will be managed.

Poverty Survey

The Equality Committee is eager to continue to capture members' perceptions of the impact of poverty and its effects within Scottish education. For this reason, we are asking members to complete a short survey to support EIS campaigning, policy and professional learning on this vital issue.

Members' views will contribute to EIS research on the effects of poverty within education and will support our work going forward in a number of associated areas. EIS Learning Reps: New Course Launching This Summer

EIS Learning Reps work with members to support them on professional learning issues, ensure access to high quality training opportunities, and take forward the professional learning agenda in the workplace. The new Learning Reps course begins this August, with online modules taking place from September onwards. New Additional Support for Learning (ASL) Report

ASL provision has been the subject of intense scrutiny in Scotland in recent years. This scrutiny is likely to be sustained as the complexity of needs among the learning population grows, against a backdrop of under-invested public services. The EIS has published a new report which summates EIS policy on ASL and shares our concerns about undervaluing; under-investing; rising need; and the implications of broader educational issues.
