Message from the General Secretary

Dear EIS Representative,

I would like to take the opportunity with this final mailing for 2017, to thank you for your work on behalf of members over this session, and indeed calendar year, and to wish you a restful and enjoyable break.

As you can see from the enclosures, we anticipate that the 2017 pay deal will be signed off on the 18th (the proposal is for a 1% plus 1% deal i.e. 1% backdated to April and then 2% moving forward from January). This is still below inflation, however, so, with the public sector pay cap now being lifted, the 2018 Pay Campaign will be launched with the aim of building membership engagement around a restorative pay claim, potentially leading to members being balloted on industrial action.

More to follow in January - before that enjoy your holiday!

GTCS Elections

As in previous years, the EIS is supporting a number of our members as candidates in the forthcoming GTCS Council elections. We are supporting 11 nominations with the aim of seeing an EIS-endorsed candidate in each of the 11 vacancies for GTCS Council.

This year, the GTCS elections are of even greater importance. The Scottish Government's proposal for the creation of an Education Workforce Council to replace the GTCS poses many risks to the power of teacher voice in shaping teacher professionalism and professional standards. It would remove the teacher majority on the Council and replace it with a Board, similar to the current arrangement for the SQA – In other words, less teacher input and more political direction. The EIS will seek to defend the GTCS from such political interference. It will be essential, therefore, that EIS members give full backing to the 10 EIS-supported candidates (one has been elected unopposed in the FE category) when voting gets underway in January.

EIS Page Scholarship 2018/19

Application forms are now available for the 2018/19 Page Scholarship involving a research visit to America, offered by the EIS in association with the English-Speaking Union. Besides being EIS members, applicants must also have 5 years' teaching experience.

The Scholarship is awarded annually to a teacher/lecturer in a Scottish school/college and is intended to promote small-scale educational research and exchange of ideas between Britain and America. The successful Scholar travels to the USA to study a specific aspect of American education which interests her/him, and which is relevant to her/his own professional responsibilities here in Scotland.

The value of the EIS Page Scholarship is £2,400 which covers the cost of travel to and accommodation in, the USA. Throughout the visit, the Scholar is the guest of the American Branches of the English-Speaking Union.

The closing date for submission of applications to the EIS Education Department is Thursday 1 March 2018.

EIS Action Research Grants 2018

The current cohort of EIS researchers met after the Professional Learning conference in September, and will report on an interesting and varied set of research topics in May 2018. The EIS will again be offering research grants in 2018 with application information to be circulated in the new year.

Educational establishment-based action research is a simple set of techniques used to help improve teaching and learning. It is usually undertaken by the teacher or educator in their own classroom / setting. Action research involves:

- Identifying an issue (related to learning in your classroom / setting)
- Reviewing any relevant literature around the issue
- Planning a simple research strategy

- Gathering and analysing data
- Taking action based on your findings
- Sharing your findings.
