Our independent scrutineers' report, as required in accordance with section 231B of the Trade Union and Labour Relations (Consolidation) Act 1992, for the above ballot which closed at **noon on Wednesday, 14 January 2026** is as follows:-

Number of individuals who were entitled to vote in the ballot **48212**

Number of votes cast in the ballot **22450**

Votes cast in the ballot as a % of individuals who were entitled to vote **46.57%**

**Are you prepared to take part in industrial action consisting of action short of strike (ASOS) in pursuit of the SNCT Workload Dispute?**

Number of spoilt or otherwise invalid voting papers returned **55**

#### Result of Voting

Yes **20849 93.10%**

No **1546 6.90%**

**“Yes” votes as a % of individuals who were entitled to vote** **43.24%**

#### We are satisfied:

- a) that there are no reasonable grounds for believing that there was any contravention of a requirement imposed by or under any enactment in relation to the ballot
- b) that the arrangements made with respect to the production, storage, distribution, return or other handling of the voting papers used in the ballot, and the arrangements for the counting of the votes, included all such security arrangements as were reasonably practicable for the purpose of minimizing the risk that any unfairness or malpractice might occur,
- c) that we have been able to carry out the functions conferred on us under section 226B(1) without any interference from the trade union or any of its members, officials or employees.
