THE NATIONAL DEAL HAS BEEN RATIFIED!

Colleges Scotland and your union, EIS/FELA, have ratified an agreement on the national instructors dispute.

This agreement was reached following your strike action, and campaigning — well done, your solidarity, unity and commitment have won the day.

This agreement answers the question which we have been asking candidates in the election —

Do you agree that where a person is preparing for, teaching, and assessing students, they should be recognised as a lecturer?

In the deal agreed at the NJNC today both sides accept that "Roles which require staff to plan and prepare the learning experience, teach and facilitate learning, and assessment, as detailed within the Role Profile, should be capable of discharging all 6 key responsibilities and attributes and therefore are considered employed under the terms of the NWPA: Staff Terms and Conditions (Lecturing) 1st August 2019."

This agreement includes a commitment from the employers that there will be no national plan to replace lecturers with instructors, and sets out a procedure for dealing with issues which may arise regarding differentiation of roles. Further it confirms the status of national agreements.

National training will take place for Branch Officials to ensure that every branch is clear on what this agreement means at a local level.

A consultative ballot of members will open soon; your Executive is recommending that you support this deal by voting yes.

This will be an online ballot and your will receive your ballot via the email address which you have registered with the EIS. Please check that your member details are up to date to ensure that you receive your ballot.

While the National dispute has been settled successfully, a number of local disputes continue across the country and in particular at Forth Valley College, where members are on strike for the 11th day in their dispute over FIRE AND REHIRE tactics, and at West Lothian College where ASOS is taking place over the use of instructor posts. 27 members have been forced on to instructor grade posts and the branch are striking for the reinstatement of these members on lecturing terms and conditions.

Recent reports of the terrible stress which

At an online meeting yesterday our General Secretary Larry Flanagan stated that "EIS will stand behind Forth Valley members for as long as it takes to end this dispute!"

We believe that the National deal will assist in resolving this dispute but members at FVC are continuing their fight to have their colleagues reinstated as quickly as possible.
